Print Rules: A Photo Travel Print entry shall be a maximum of four (4) prints unmounted or four lightweight mounts **not** over 8½ x12 inches. Prints may be mono-chrome or color or mixed at the discretion of the exhibitor. Prints may be home or commercially processed.

Photo Travel Definition: Subject matter must portray photo travel. A photo travel photograph must express the feeling of a time and place, portray a land, its people, or a culture in its natural state, and has no geographical limitations. Ultra close-ups which lose their identity, studio type model shots or photographic manipulations which misrepresent the true situation or alter the content of the image are unacceptable in Photo Travel competition.

Titles: Titles will not be read aloud at judging and are limited to 35 characters.

Non-Return of Prints: In recent years the cost of postage has increased significantly and rapidly. This has discouraged many print exhibitors.

When one considers the rather limited life of most prints sent to exhibitions, the cost of postage and the ease of making a new digital print, there may be significant net savings to the exhibitor by electing to use PSA's new "Non-Return of Prints" option.

In the case of Photo Travel, a PSA member anywhere in the world may enter 8 images for \$5 vs. \$15 or \$20 for the return option. That's quite a savings. If you elect this option, then we must have your signature authorizing the destruction of your prints after the exhibition. Please sign in the upper right hand box on the actual entry form.
